

# Attend, engage, attain, excel

A plan for every child



## EDUCATION, HEALTH AND CARE PLAN

- Children requiring support from education, health and children's social care — including children with (learning) disabilities. Automatic for those with life-long or life-limiting conditions, children with complex needs (including some looked after children living away from home or growing up in institutions), and children requiring residential provision. With a national statutory threshold for s.17.
- Joint funding from education, health and children's social care, and addition funding through Local Specialist Support Fund.
- No child loses support. Every child that currently has an Education, Health and Care Plan keeps it.



## EDUCATION PLAN

- Enhanced targeted support for children who find learning hard, including all children who are not school ready, have low prior attainment, or do not make the expected standard of development
- For children with poor attendance, at risk of disengagement, or who have been suspended or excluded (managed by the local authority or receiving school — AP from day one, no exclusion home for CIN)
- Time-limited plan, managed by the mainstream school
- Funded through inclusion premium
- Data published at school and LA level for attendance and outcomes.



## EDUCATION & CARE PLAN

- All children receiving statutory support from children's social care, with a national statutory threshold for s.17.
- Replaces the Personal Education Plan (PEP) for looked after children
- All children receive Pupil Premium Plus and support from the Virtual School
- Named school and priority admissions
- Data published at school and local authority levels for attendance and attainment
- Funded through inclusion premium
- Data published at school and LA level for attendance and outcomes.



## EDUCATION & HEALTH PLAN

- For children requiring multi-agency support from education and health
- Including children with long-term health conditions, acute medical conditions such as cancer,
- receiving mental health support through CAMHS, or chronic conditions such as cystic fibrosis.
- They may find learning hard, require reasonable adjustments, or need a coordinated plan across health and education.
- The health elements are funded through the ICB, and the education support through the Inclusion Premium.
- Mainstream by default, with support from hospital schools or AP as appropriate
- Funded through inclusion premium
- Data published at school and LA level for attendance and outcomes.



## PUPIL PREMIUM

- For children from low-income households and Ever CIN
- Eligibility extended to those with wider vulnerability flags including children in temporary accommodation, who are homeless, with a parent in prison, young carers, and those in kinship care
- Auto-enrolment via Unique ID
- Money goes directly to schools with accountability through Ofsted and governance arrangements



## ALL CHILDREN

- High quality adaptive teaching
- School funding with a revised pastoral offer (including at groups of schools or local authority level)
- Access to Educational Psychologists, Speech and Language Therapy (SaLT),
- Mental Health Support Teams, Family Support Workers, and School Nurses

**Note:** All plans are standardised and digitised, and accessible for parents on the Parent Portal, and for schools through the MIS. Each child has a single digital record and is part of a unique ID. Plans are based on quality first teaching and evidence-based interventions
